SELECTION PROCEDURE:-

- 1. The question paper & the answer key of each written test shall be uploaded on the website on the next day of the examination for calling objections, if any, from the candidates, who can submit their objections within 03 days through website with proof. Thereafter objections will be referred to experts and key will be finalized for preparation of result, which will also be uploaded on the website.
- 2. No candidates will be considered to have qualified in the written test unless or until he/she obtained at least qualifying 50% marks in Written Examination.
- 3. Marks obtained by the candidates in written test will be uploaded on the website.
- 4. Merit list shall be prepared on the basis of marks obtained in the written test and will be uploaded on the website and on the basis of merit, the candidates will be called for Counseling as per their merit in the ratio of 1:3.
- 5. The candidates scoring higher merit will be considered against the posts in question. A waiting list shall also be maintained. In case, the selected candidate fails to join the post due to any reason within a period of the one month (4 months in exceptional

- circumstances with prior approval of the competent authority) his/ her candidature will be cancelled and the candidates in waiting list shall be offered appointment till all the notified vacancies are filled up.
- 6. In case two or more candidates secure equal merit, then the candidates older in age will rank higher in the order of merit list at the time of final selection.
- 7. In case two or more candidates secure equal merit and their date of birth may happen to be the same then the candidates having higher percentage in educational qualification shall rank higher in the order of merit list at the time of final selection.

GENERAL INSTURCTIONS:-

- 1. Examination centers for written test will be notified at the time of downloading of admit card-cum-Roll No. slip.
