Notification

No. GRIID/Estt./366/2018/1100.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, the President of India makes the following rules regulating the method of recruitment to Group 'A' posts (Non-Ministerial) in the Department of Government Rehabilitation Institute for Intellectual Disabilities, Chandigarh, namely :—

1. **Short title and commencement.**—(i) These rules may be called the Government Rehabilitation Institute for Intellectual Disabilities, Chandigarh (Non-Ministerial Cadre Group 'A' posts), Recruitment Rules, 2016.

(ii) They shall come into force on the date of their publication in the Chandigarh Administration Gazette.

2. **Application.**—These rules shall apply to the posts specified in column 1 of the Schedule annexed to these rules.

3. **Number of posts, classification and scale of pay.**—The number of said posts, their classification and the scales of pay shall be as specified in columns 2 to 4 of the said Schedule.

4. **Method of recruitment, age limit, qualifications etc.**—The method of the recruitment to the said posts, age limit, qualifications and other matters concerned therewith shall be as specified in columns 5 to 13 of the said schedule.

5. **Disqualification.**—No person :

(a) who has entered into or contracted a marriage with a person having a spouse living ;

Or

(b) who, having a spouse living, has entered into or contracted a marriage, with any person shall be eligible for the appointment to the said posts :

Provided that the Administrator, Union Territory, Chandigarh may, if satisfied that such marriage is permissible under the personal Law applicable to such person and other party to the marriage and there are other grounds for so doing, exempt, any person from the operation of this rule.

6. **Powers to relax.**—Where the Central Government is of the opinion that it is necessary or expedient so to do, he may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules in respect of any class or category of persons.

7. **Savings.**—Nothing in these rules shall effect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Chandigarh Administration from time to time in this regard.

Note 2.—The Period of Deputation (ISTC) including the period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ Department of the Central Government shall ordinarily not to exceed three years the maximum age limit for appointment by Deputation (ISTC) shall be not exceed 56 years as on the closing date of receipt of applications).
