In order to train qualified teaching/training personnel in the field of Intellectual Disabilities, this Institute has already started recognized courses of Rehabilitation Council of India, New Delhi i.e. Diploma, Degree courses such as D.Ed., B.Ed. and M.Ed. in Special Education (Mental Retardation) in GRIID, Sector 31, Chandigarh. The D.Ed. course is affiliated with the National Institute for Empowerment of Persons with Multiple Disabilities (NIEPD), Chennai whereas B.Ed & M.Ed. Degree courses in Special Education are affiliated to Panjab University, Chandigarh. All the three courses are recognized by Rehabilitation Council of India (RCI), New Delhi, a statutory body of Govt. of India under the parliament Act 1992. GRIID is one of the oldest and only teachers training Institution of RCI running M.Ed., B.Ed. & D.Ed. in special education (Intellectual Disability) in Northern region. It is mandatory for a college to have a Comprehensive Special School and Clinical Services in order to run courses recognized by Rehabilitation Council of India. GRIID has a well established school where near about 450 children with Intellectual Disability, Autism, Cerebral Palsy and Multiple Disabilities are being Trained, Educated and Rehabilitated. The comprehensive services being offered at GRIID helps the college students to have better exposure, understanding and an opportunity to learn the clinical skills. The details of the courses being offered at GRIID are as follows:-

#### M.Ed. Special Education - Intellectual Disability:-

The Panjab University, Chandigarh has granted affiliation to GRIID to run two years M.Ed. Special Education - Intellectual Disability with 10 seats. Eligibility to seek admission in the said course is B.Ed. Special Education - Intellectual Disability with 50% marks or its equivalent from a recognized University.

#### **B.Ed. Special Education - Intellectual Disability:-**

The Panjab University, Chandigarh has granted affiliation to GRIID to run two years B.Ed. Special Education - Intellectual Disability with 30 seats. Eligibility to seek admission in the said course is graduation with 50% marks in any discipline from a recognized University.

#### D.Ed. Special Education - Intellectual Disability:-

Every year a fresh batch of 30 students is enrolled in the Academic Session through online Aptitude

Test conducted by RCI. Eligibility to seek admission is intermediate from any board.

#### National/State Conference, Seminars & Continued Rehabilitation Education:-

GRIID is also contributing in the responsibility to update and upgrade the knowledge & skills of professionals working in different areas of intellectual disabilities in nearby states. GRIID conducts National conferences, Seminars and Continuing Rehabilitation Education (CRE) topics and Programmes for the teachers, parents of special children and other stakeholders to upgrade their knowledge and skills in the field of disability from time to time.

#### **National Service Scheme (NSS):-**

The cardinal principle of the NSS Programme is that it is organized by the students themselves, students through their combined participation in community service, get a sense of involvement in the tasks of nationa building. Every year students of D.Ed., B.Ed. & M.Ed. Special Education voluntary giving their best services in community based rehabilitation under the banner of NSS and are supporting for comprehensive rehabilitation of persons with disabilities as well as needy persons in and around Chandigarh.

#### **SCHOOL WING:-**

Special education plays a crucial role in the development of persons with Intellectual Disability. At GRIID school, comprehensive training is being imparted by Special Educators and Vocational Instructors to different levels of intellectual disability in order to develop their Personal, Social, Academic and Adaptive skills. Presently there are about 500 students with Intellectual Disability from the different categories i.e Cerebral Palsy, Children with Down syndrome and Children with Autism. Children come to take admission from all over the country. There is a hostel facility for persons with Intellectual Disability who come from places other than tricity. i.e. Chandigarh, Mohali and Panchkula. For commuting of students of hostel and day scholars from home to school and school to home, bus facility is also available. An ambulance is also available for students for medical emergency purposes.

In special school, there are 36 sections in which training and education is imparted to the students admitted in various sections such as Play, Autism, Primary, Secondary, Pre-Vocational and Vocational. There are dining rooms on each floor in which children of various sections eat together. With an objective to provide inclusive Education, School Readiness Program is being run in two sections for 3-7 year old students to mainstream them in

the normal education system.

There is a section especially for Intellectual Disability persons having Autism. As Autism core deficits areas are Communication, Socialization and Repetitive Behaviour, so these children are given training to increase social and communication skills and reduce Repetitive Behaviours. Each student is assessed on Standardized Assessment Tools and on the basis of it, an Individualized Education programme is planned after detailed discussion with parents.

Promotion to the next section is based on 80% achievement of the curriculum planned for the section. e. g. the child who is in primary section shall be promoted to the secondary section after having achieved 80% of the educational plan set up for him/her by the class teacher. From secondary, he/she is promoted to Prevocational wherein training in pre-requisites and functional academics required for the vocational trades are given.

Students above 18 years are trained in the area of occupational and social skills to make them economically independent in life. Training is imparted in the trades like Candle Making, Chair Recanning, Masala Grinding and Packing, Making pots, Carpentry, Book Binding, Cutting and Tailoring, Paper Recycling, Cooking and Bakery, Making Jewellery and Organic Farming.

With an aim of overall development of persons with intellectual disability, co-curricular activities such as Yoga, Dance, Music, Gym and Sports activities have also been organized in this Institute, the details of which are as under:-

Yoga:- Students are trained in yogic practices such as Asanas, Pranayama, Kriyas, Mudras and taught yogic rules-yama and niyama with an aim of providing holistic health. They are prepared in yoga dance demonstrations to perform in various functions and participate in International Day of Yoga

**Gym:-** Programmes such as Aerobics, Treadmill, Twister, Cross Trainer Cycling, Sit ups sessions are available in Gym. Focusing areas are weight reduction programme, cardiovascular endurance, increase flexibility and physical strength and development of physical and mental health

<u>Dance</u>:- Students learn to dance according to their special ability and interest. Students are taught different forms of Dance like Giddha, Bhangra, Folk, Patriotic, Saraswati Vandana and action songs. Most of the students have got good Rhythm and enjoy dance very much. Dance has a therapeutic effect for students with aggressive behaviour as it helps them to release the pent up emotions.

Instrumental and Vocal Section:- Students are taught to play instruments like congo, bongo, dholak, dhol, table, duff, banjaree, harmonium, keyboard, flute, patti-tarang, miracus, according to the special ability and interest of a child. Moreover, students who are able to sing are taught various forms of singing like classical music, composition songs, devotional songs, shabads, ghazals, folk, patriotic songs etc.

**Sports:-** Sports caters to the physical, mental, emotional and social needs of the persons with Intellectual Disability. Students have participated in various games such as netball, floorball, golf, floor hockey, alpine skiing, snow boarding, football, basketball, cricket, softball, throwball and badminton. They have won many awards at state, national and international level.

Each class has a Special Educator and an attendant as supportive staff to enable the proper management of students with intellectual disabilities having associated problems. There are 5 floors in GRIID school building. Each floor of GRIID school building has a security guard etc.

Note:- As per the Rehabilitation Council of India norms the student teacher ratio should be 1:8. For Sever students with Intellectual Disability should be 1:4.

#### **CLINIC WING:-**

The Child Development Clinic of GRIID was established with the aim of providing medical facilities to children with Intellectual Disability, Autism, Cerebral Palsy and Multiple Disabilities, i.e the disabilities covered under the National Trust Act (1999). Till date more than 10,000 children have availed the services of child development Clinic of GRIID.

#### The Services Provided by Clinic are:-

- 1. Diagnosis and Management of the four above mentioned conditions including management of comorbidities including provision of free medicines for seizures and behaviour management.
- 2. Vision screening
- 3. Hearing screening
- 4. Therapies (Speech, Occupational, Physiotherapy, Behavioural Therapy, Sensory Integration)
- 5. Special Education to OPD children above 3 years of age
- **6.** IQ and autism assessment
- 7. Certification (Disability certificate and UDID i.e., Unique Disability Identity Cards, Railway concession

certificate etc.)

- **8.** Telecounselling and Videoconferencing for out station patients.
- 9. Community based Rehabilitation.

#### The Multidisciplinary Team of Clinic consists of:-

- 1. Child Specialist
- 2. Psychiatrist
- 3. Clinical Psychologists
- 4. Special Educators
- 5. Speech therapists and audiologists
- 6. Physiotherapists
- 7. Occupational therapists
- 8. Optometrist
- 9. Medical Social Worker

The children with intellectual disability or developmental delay are seen in the OPD where they are assessed by various team members and individual management plan for each child as per his/her needs is made. The children are called for follow ups as per need and also given home based treatment plans. For outstation patients, Telecounselling and Videoconferencing services are being provided.

After assessment of disability, the parents apply for disability and UDID cards through http://www.swavlambancard.gov.in in website of government of which GRIID is also one of the approved centers in Chandigarh.

#### **THERAPIES:**

### **SPEECH THERAPY:-**

Assessment & Management of Speech and Language Disorders such as Articulation Disorders, Fluency Disorders, Voice Disorders, Deviant language, and Receptive and Expressive Language Delays etc. The Speech Therapists provide their services for intensive Speech Stimulation, Auditory Training, Communication Disorders and other Speech and Language Delays.

#### **PHYSIOTHERAPY:-**

Assessment and Management of Musculo-Skeletal Disorders, Deficits in Gross Motor Skills,

Locomotors Impairments and other Neuro Muscular Disorders by a Physiotherapist.

#### **OCCUPATIONAL THERAPY:-**

Assessment and Management of Fine Motor Skills, Psycho-Social Skills, Cognitive and Perceptual skills by an Occupational Therapist, the treatment includes provision of Aids and Appliances.

#### **SPECIAL EDUCATION:-**

Assessment and training of Adaptive skills by a Special Educator for children above 3 yrs. of age including training of Personal, Social and Academic skills. Functional assessment and planning for future training including special education, inclusion, pre-vocational and vocational training is also provided.

#### **BEHAVIOUR THERAPY:-**

IQ assessment for severity of disability and management of associated Behavioural problems in the form of Behavioural modification therapy and ABA are done by a Clinical Psychologist. IQ certificates are issued only to those who have IQ below 70. Online application of disability certificates and UDID are done on swavlambhancard.gov.in.

#### **DOCTORS:-**

Paediatrician and Psychiatrist- for management of causes and co-morbidities like behaviour problems and seizures.

### **IQ ASSESSMENT AND I.Q CERTIFICATE:-**

I.Q assessment for severity of disability and management of associated Behavioural problems in the form of Behavioural modification therapy and ABA by a Clinical Psychologist. IQ certificates are issued only to those who have IQ below 70.

#### **OPTOMETRY UNIT:-**

Assessment and Management of Visual Acuity, Errors of Refraction (including Cyclopaedic

Refraction/Retinoscopy), Phoria's, Squint, Nystagmus by Optometrist.

#### **SPECIAL CLINICS**

#### **DOWN SYNDROME CLINIC:-**

Down syndrome Clinic is being run by this Institute to assess the Degree of Children for Intellectually Disability and other physical deficits. Specialist consultations are being given from GMCH-32. Children are also given special down syndroms cards and are followed up regularly in the clinic.

#### **PSYCHIATRIC CLINIC:**

In this clinic a Psychiatrist accesses children for Psychiatric and Behavioural co-morbidities and manages accordingly.

#### **EARLY INTERVENTION PROGRAMME:-**

Early Intervention Clinic helps to detect early signs of delayed developmental milestones in children aged 0-6 years. The services provided under this Programme help these children to develop and enhance various skills such as social & interpersonal skills, play skills, gross and fine motor skills. Early identification and early intervention helps a child with special needs to reach his/her fullest potential and limits the extent of physical handicap to provide better quality of life.

#### **MOTHER & CHILD PROGRAMME:-**

This Programme provides 90 hrs of structured sessions, educating the mothers to help and improve the deficient skills, cognitive thinking, play skills and adaptive skills. The multi Professional Team helps the mother to understand the strengths and needs of her child. Children who have specific medical disorders such as visual and hearing impairment, Down's syndrome, other congenital malformations and ones who are born as premature, low birth weight babies are at risk for developmental delays and require early stimulation by the parents in home environment.

#### **TELE-COUNSELLING SERVICES:-**

This service is provided by the multi-disciplinary team of Child Development Clinic of GRIID for the parents from the neighbouring states for answering the queries, who are not able to bring their child for therapies at the institute experts include Clinical Psychologist, Social Worker, Special Educator, Occupational Therapist and Speech Therapist. These families can call HELPLINE No. 0172-2637361 on every Friday between 1:00 PM to 3:00PM.

#### **AUTISM CLINIC:-**

Children with autism may have mild intellectual deficits or have average or above intelligence. The Autism clinic at GRIID provides a complete evaluation of cognitive strengths and deficits, degree of autism by using a standardized tool and comprehensive management plan and therapies such as sensory integration therapy, parental counselling and Behaviour therapy. The team also helps the parents to develop an ADL activity schedule and guidance for education for these children.

#### **COMMUNITY OUTREACH PROGRAMME:-**

Community outreach programme provides rehabilitation services to the people who are unable to avail these services at GRIID due to various reasons. The team comprises of Speech Therapist, Social Worker, Occupational Therapist, Special Educator and Clinical psychologist. The facility including evaluation, therapies, disability assessment and certification at the community level so that Persons with intellectual disabilities at the various age ranges and IQ level will be benefited and can avail of the services at their remote locations. Community Outreach Program is also providing special education services It accelerates awareness and reducing the occurrence of disability by making people aware.

GRIID is also liasoning and networking with various stakeholders for the effective implementation and utilization of existing resources for the community rehabilitation of persons with intellectual disabilities at their remote areas like various Anaganwari centres at Khuda Lahora, Bapudham Colony, Kishangarh, Khajheri, Manimajra, Maloya, Burail, Khuda Jassu, Behlana, Makhanmajra, Kaimbwala, Palsora, Maulijagran, Mauli jagran complex, Indira Colony, Dadu majra, Hallo Majra, Ramdarbar, Dhanas, Maloya, Modern Complex-Mani majra, Raipur-Khurd.
