CORRIGENDUM TO PUBLIC APPOINTMENT NOTICE

Public Appointment Notice Reference No. GRIID/Estt./2016/5585 dated 24.10.2016

This is corrigendum to the Public Appointment Notice mentioned above, published in various newspapers and website of this institute on 24.10.2016 for filling up various Group-C posts in Govt. Rehabilitation Institute for Intellectual Disabilities (GRIID), Sector-31, Chandigarh.

It is informed that the Govt. of Punjab, Finance Department (Finance Personnel-1 Branch) vide letter No. 7/42/2020-5FP1/741-746 dated 17.07.2020 issued instructions regarding New Pay Scales for the fresh recruitment/ appointment in the service of Government of Punjab or its entities thereof. By virtue of notification dated 13.01.1992 of Govt. of India, MHA, the Chandigarh Administration, Finance Department has adopted the above mentioned instructions of Govt. of Punjab in respect of employees of Chandigarh Administration vide letter bearing No. 7000/1/2-F&PO(7)/2020/12240 dated 17.09.2020. The recruitment process for the 01 post of Technical Person (Supervisor) advertised vide public appointment notice mentioned above was withheld due to pending court case and therefore, the same remained under process at the time of issuance of the above said instructions dated 17.07.2020.

In terms of the above instructions, the New Pay Scale/ Matrix for the post of Technical Person (Supervisor) in GRIID, Sector-31, Chandigarh have now been notified in the official Gazette of Chandigarh Administration vide Notification No. GRIID/Estt./360/2021/6026 dated 08.11.2021.

As per above decision of the Chandigarh Administration, the new pay scale/ Matrix for the post of Technical Person (Supervisor) is as under and the same is also applicable to this recruitment of Technical Person (Supervisor) instead of pay scales mentioned in the public appointment notice referred above, subject to the conditions as mentioned in the notification dated 08.11.2021 mentioned above:-
